

## CROWS NO MORE! PROJECT

Activity Report – August 2025, Eric Kinoti, Colin Jackson

### Summary

The CMN team this month killed **6,818** House Crows across the project area. The new poison batch is now in the hands of KWS, Nairobi and soon to be in KWS Mombasa HQ. The Lamu team is also successfully running a small eradication programme. The Kilifi motorbike is now fully operational and making a real difference. ### Crows No More

Our team this month killed **6,818** House Crows, leading to an accumulative total of **58,625** House Crows killed so far. We have been making bigger strides as we go ahead. After the KWS stakeholder meeting in July, KWS took the responsibility of taking over the custody of the bought poison. *Good news*, the poison has now been received by KWS and will be transported to the KWS armoury at Mombasa Marine Park in September. It will be readily available upon request by A Rocha Kenya through the Crows No More Co-ordinator following the agreed protocols.

Having a new batch of poison available now means only one thing: starting the south coast, Mombasa / Mariakani / Mtwapa and Mombasa road to be able to cover the Mtwapa-LungaLunga gap. This is where there are a *lot* of House Crows and thus a huge problem. We are finalising the budgets so that we can really motivate stakeholders to fund the next stage of crow eradication.



August saw us visit Lamu to help the team there as they continue to eradicate this invasive species. They have far fewer crows than further south, but it's important to get rid of even these now. We trained the team there to be able to prebait and find better spots to poison and how to get better results. The Kilifi motorbike is finally operational and will hugely change our work, as poisonings can now happen daily. The bike will be used to do "guerrilla poisonings" from Chumani to Mavueni. There are small populations that reside inside town and would really be good to poison daily on their 'natural' feeding grounds like fish kiosks, roadside kiosks or in front of butcheries, etc.






## Fundraising and accounting

### June, July, August fundraising and Expenditure

As always, we are very grateful to our supporters, who have continued to have confidence in *Crows No More!* In **August**, we raised a total of **298,750**. THANK YOU! However, as a reminder, we still haven't reached our monthly target. We need approximately Ksh **490,000** per month for the basic regular costs if we are to do it as widely and effectively as possible. Looking at the pie charts below, we had to cut out most of our activities, which will affect the level of poisoning we can do but you will see we had to cut back on the awareness programme (orange slice in the pie). Please see June and July on the last page.

We have been greatly appreciative of the donations received to date. We continue to urge you that a budget of Ksh 490,000 per month is such that it absorbs one-off donations immediately. The best kind of support is the regular, committed donations that a number of hotels and some individuals make. If we could get another **30-40 individuals** and **10-15 hotels or businesses** to commit to between **Ksh 2,000** and **Ksh 10,000** per month respectively, it would allow the poisoning to really move ahead.
